Minutes of the meeting of the **Kessingland Parish Council** **Held at 7.00pm on Wednesday 8th October 2025** In the Council Chamber, Marram Green

93. Chair's welcome

The Chair welcomed the Committee and explained the meeting protocol.

94. Apologies for absence.

Apologies for absence were received from Cllrs Ladd, Saunders, Graham & Pope-Brannon. Acceptance of apologies for absence was proposed by Cllr McLean, seconded by Cllr Glendinning with all in favour.

95. Declarations of Interest.

There were no declarations of Disclosable Pecuniary, Other Registerable and Non-Registerable Interests from Councillors on items on the agenda and it was noted that there are no written requests for dispensations for Disclosable Pecuniary Interests. Dispensations have been granted to the following:

- Cllr Green in respect of his role as District Councillor & Church Warden

96. Minutes of the previous meetings.

The minutes of the meeting held on the 10th September 2025 had not been circulated therefore they will be brought to the next meeting.

97. Reports

97.1 No report was received from Suffolk County Council.

97.2 A report was received from East Suffolk Councillor Alan Green. He informed the Council that, starting from June 2026, East Suffolk Council will be providing residents with an additional wheelie bin and a separate food waste bin. He also announced a proposal to establish three unitary councils across

Suffolk, aimed at delivering improved services at a lower cost compared to the current system. Under this arrangement, a single council would be responsible for all local services within each area.

98. Public Forum

No members of the public attended.

99. Leisure, Communications & Events

- 99.1 Cllrs noted the minutes of the Leisure, Communications & Events meeting held on the 15th September 2025 will be considered at the next meeting.
- 99.2 An update on Roy Browns Garden was given by Cllr Nicholls. The new barrels have been received and are ready to be delivered to the garden. Bulbs have been purchased and should be planted by next week. A request for another water butt was given.
- 99.3 Cllrs considered a location for a new defibrillator in the village should the councils application for a free one be successful. Cllr Boyle proposed that it would replace the one currently at Marram Green. This was seconded by Cllr McLean with all in favour.
- 99.4 Councillors considered a request to install lighting in the overflow car park on Francis Road. A meeting with the KSSC is required to gather additional information.

100. Audit

- 100.1 The External Audit Report 2024-25 was received. Cllr James gave thanks to the Acting Parish Clerk and Cllr Graham for their work involved updating the Asset Register.

101. Finance & Governance

- 101.1 Cllrs noted the minutes of the Finance & Governance meeting held on 9th September 2025 will be considered at the next meeting.

102. Personnel

- 102.1 Cllrs noted a meeting of the Personnel committee took place on 11th August 2025 and the minutes will be considered at the next meeting.
- 102.2 Cllrs noted the resignation from a Youth Café Leader and that the recruitment process for a replacement has begun.

104. Other Council Business

- 104.1 As there were no volunteers for the role of Safeguarding Lead, Cllr James proposed Cllr Glendinning to serve in the position on an interim basis. This was seconded by Cllr Boyle with all in favour.
- 104.2 To consider a compensation claim for an incident at Church Road play area. (Confidential)

105. Other matters

A discussion took place regarding the goalposts at KSSC. A meeting is going to be arranged with the two football clubs to reach an agreement concerning the use of the facilities.
